The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors found that simultaneous partial</p>	[Y]

splenectomy during liver transplantation is an effective treatment and should be used for advanced cirrhosis patients combined with severe splenomegaly and hypersplenism; and (3) Format: There are 4 tables and 5 figures. A total of 17 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by SageSCI was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; Tianjin Natural Science Foundation; National Science Fund for Distinguished Young Scholars; Spring bud plan of tianjin first central hospital. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
