The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reported the prevalence and clinical characteristics of COVID-19 infection in inpatients with schizophrenia. However, the language needs to be revised. The questions raised by the reviewer should be answered; and (3) Format: There are 3 tables. (4) References: A total of 36 references are cited, including 21 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorial office@wjgnet.com.
