Science Editor: 1 Scientific quality: The manuscript describes a randomized controlled trial of the influence of decision aids on decisional conflict in patients with hip or knee osteoarthritis. The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This appears to be a well conceived and well conducted RCT. The authors were unfortunate to experience a considerable drop-out till the end of the trial (26 weeks), however, they correctly refrained from making any inference based on the 26-week data. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 1 figure. (4) References: A total of 19 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The topic has not previously been published in the WJO.</p> <p>5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The “Author Contributions” section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Orthopedics, and the manuscript is conditionally accepted.
