Science Editor: 1 Scientific quality: The manuscript describes a randomized controlled trial of the influence of decision aids on decisional conflict in patients with hip or knee osteoarthritis. The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This appears to be a well concieved and well conducted RCT. The authors were unfortunate to experience a considerable drop-out till the end of the trial (26 weeks), however, they correctly refrained from making any inference based on the 26-week data. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 1 figure. (4) References: A total of 19 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorial office@wjgnet.com.
