While the study included a relatively large number of sample size, the study lack significant on the clear jaundice and native liver survival between lap PE vs. open PE, that are the main focus of treatment of BA and have been systematically reviewed currently. The topic is within the scope of the WJG. (1) Classification: Grade B; Grade D; Grade C (2) Summary of the Peer-Review Report: I think the article needs a major re-write. I have tried to help in certain areas but further work is required; (3) Format: There are 03 tables and no figures; (4) References: A total of 18 references are cited, including 07 references published in the last 3 years; (5) Self-cited references: There are 02 self-cited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (6) References recommendations: The authors have the right to refuse to cite improper references recommended
