Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the prognostic value of left atrial size in hypertensive African Americans undergoing stress echocardiography. The topic is within the scope of the WJC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The paper is well written, but need some minor revision: Editing, improvement in discussions to emphasize the significance of their findings for the clinical practice. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. (4) References: A total of 40 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable selfcitations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
