	<p>This is a well written manuscript, and few concerns by the reviewer should be addressed. 1 Scientific quality: The topic is within the scope of the WJG. (1) Classification: Grade C. (2) Summary of the Peer-Review Report: Generally, this is a well written article, but few concerns raised by the reviewer should be answered. (3) Format: There are 3 tables and 3 figures; (4) References: A total of 30 references are cited. (5) Self-cited references: 0. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: Nil. 5 Issues raised: Nil. 6 Re-Review: not required. 7 Recommendation: minor revision.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
