I think this review is useful for audience. However, some aspects need to be confirmed by another microbiologists that I am not. Also, the confirmation of evidence base those pointed that the coccoid form of H.pylori that showed viable bacteria caused relapse of disease of Duodenal PUD and gastric PUD may be differed by other factors, not only the form of bacteria. To confirm the actual evidence, the author should show the review or summary table of recent clinical studies related to prevalence of both types of PUD & detection of resistance strain or active recurrent infection after eradication.
