“Time line of the history” may be shortened using daily basis of events; avoiding same day repeats; there are tree repeats on 08/25/2018, 09/06/2018 and 11/08/2018. The authors should mention if there are any other symptoms of autimmune disease within the Crohn spectrum previous to the ICI administration. Does the patient have a history of colitis, family history of colitis, genetic testing? The authors should also detail the natural history commonly encountered in adverse events related to ICI doublet, notably data from RCC, lung and melanoma studies. (3) Format: 2 figures. 12 references were cited, including 7 references published in the last 3 years. No self-citation. 2 Language evaluation: 3B and A. Language editing certificate was not provided. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. The written informed consent was not properly provided. No academic misconduct was found in the Bing search. The highest single-source similarity index is 15% in the CrossCheck inveatigation, the repetitive parts should be rephrased. 4 Supplementary comments: (1)Invited manuscript. (2)Without finicial support. (3) The corresponding author has not published articles in BPG journals.(Xiao-Quan Yu)

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJGO. (1) Classification: Grade A, and three Grade C; (2) Summary

of the Peer-Review Report: Reviewer 03769117 suggested the authors to explaining more about the figures. Reviewer 03476759 suggested the authors to mention if there are any other symptoms of autoimmune disease within the Crohn spectrum previous to the ICI administration. Reviewer 03004570 suggested some minor revision about the figures and time line of the history; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by the science editor. The authors are native English speakers. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, and the Informed Consent Statement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. However, the similarity of the manuscript in CrossCheck report is a little high. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found that the author contributions is missing. Please provide the author contributions; (2) I found the key words and core tip section is missing. Please add the key words behind the abstract. Please write the "core tip" section behind of the key words; (3) I found that the "case report" section is not written according to the guideline of the journal. Please re-write the case report section (Case Presentation), and add FINAL DIAGNOSIS, TREATMENT, and OUTCOME AND FOLLOW-UP section to the main text

	<p>accordingly; (4) I found the PMID and DOI numbers are missing in the reference list. Please provide the PubMed and DOI numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found that the figures can't be edited. Please provide the original figure documents. All submitted figures, including the text contained within the figures, must be editable. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (6) as shown in the CrossCheck report, the similarity of the manuscript is a little high.
