Issues raised 6: A hyphen is required when three or more references are cited in succession. Please change ^[1,2,3,4] to ^[1-4].

Issues raised 7: No space is allowed between the text word and the reference number. Please change world ^[1,2] to world^[1,2].

Issues raised 8: The in-text numbering of references is not in order, and there are omitted citations. Please verify that each in-text reference number is arranged in ascending order, and delete duplicate reference citations.

Issues raised 9: Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. The PMID is required, and NOT the PMCID; the PMID number can be found at <https://pubmed.ncbi.nlm.nih.gov>. (Please begin with PMID:) The DOI number can be found at <http://www.crossref.org/SimpleTextQuery/>. (Please begin with DOI: 10.**).

Issues raised 10: PMID and DOI numbers of references from English-language journals. Please add a space between the PMID and DOI numbers in the square brackets.
