pericardial tamponage. The author described in detail the general condition of the patients, ultrasound diagnosis and puncture treatment, and the final prognosis was good. Through case report and analysis, it seem suggested that precise tips positioning should be carried out for PICC operations. If serious cardiac symptoms would be observed in the treatment process, POCUS should be applied timely to find delayed cardiac tamponade; and (3) Format: There is 1 figure. A total of 5 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the written informed consent and CARE Checklist-2016.
