	<b>6b</b>	Chief complaint—what prompted this visit?	__5__
	<b>6c</b>	Relevant history including past interventions and outcomes	__5__
<b>Physical Exam</b>	<b>7</b>	Relevant physical examination findings	__5__
<b>Diagnostic Assessment</b>	<b>8a</b>	Evaluations such as surveys, laboratory testing, imaging, etc.	__6__
	<b>8b</b>	Diagnostic reasoning including other diagnoses considered and challenges	__5__
	<b>8c</b>	Consider tables or figures linking assessment, diagnoses and interventions	__5__
	<b>8d</b>	Prognostic characteristics where applicable	__5__
<b>Interventions</b>	<b>9a</b>	Types such as life-style recommendations, treatments, medications, surgery	__7__
	<b>9b</b>	Intervention administration such as dosage, frequency and duration	__7__
	<b>9c</b>	Note changes in intervention with explanation	__7__
	<b>9d</b>	Other concurrent interventions	__7__
