The article is pimavanserin for the treatment of psychosis in Alzheimer's disease, within the scope of WJP.</p> <p>Summary of peer-review report: The author attempted to clarify the effectiveness and safety of pimavanserin for psychotic patients with Alzheimer's disease with a systematic review. The methodology adopted in this review is standardized and properly structured.</p>	[Y]

	<p>This is a well done, thorough review of the literature on a relatively new antipsychotic that has been used in the psychosis that sometimes accompanies Parkinson's Disease. 4 tables and 1 figure. 53 references were cited, including 11 latest references from 2017-2020. 1 self-citation article. 2 Language quality: 2A,B. 3 Academic norms and rules: Systematic Review. Copyright license agreement, PRISMA 2009 Checklist statement and Conflict-of-Interest statement files are complete and qualified. Bing search and CrossCheck are eligible. 4 Others: Without financial support. Corresponding author has not published articles in WJP. Invited manuscript.</p> <p>Editorial Office Director: Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of psychosis in Alzheimer's disease is in the scope of WJP. #00784262 pointed out that this is a well done, thorough review of the literature on a relatively new antipsychotic that has been used in the psychosis that sometimes accompanies Parkinson's Disease. The investigators reviewed its use in Alzheimer's Disease. However, #03764910 indicated because of limited number of trustworthy data, a meta analysis cannot be conducted in this research question. #02445209 pointed that the column "systematic review" isn't consist with the context of the manuscript. The questions raised by the reviewers should be answered. There are 1 figure and 4 tables in the manuscript. Fifty-three references were cited, including eleven</p>
