Risk factors for RAS and BOS were tentatively differentiated by key features. Considering the complex interaction between lymphoid tissues, pro-fibrosis environment and transplanted lungs, author</p>	[Y]

would consider to present the anatomical changes in a brief manner, following by demonstrating individual immune regulators' role in RAS or BOS. (3) Format: 2 tables and 1 figure. 97 references were cited, including 22 references published in the last three years. No self-citation. 2 Language evaluation: Grade A. Language editing certificate by edanz was provided. 3 Academic norms and rules: The conflict-of-interest disclosure form should be provided by corresponding author and Copyright License Agreement were provided.
