The topic is in the scope of WJO. (1) Classification: Grade A and C. (2) Summary of the peer-review report: This is a good but very short review article. Please expand on the content and make it more comprehensive. It would be better to convert it into a systematic review and fulfill all the PRISMA checklist items. Please add an abstract. The references are too few. I would suggest expanding the</p>	[Y]

review. (3) Format: 1 table. 47 references were cited, including 10 references published in the last three years. No self-citation. 2 Language evaluation: Grade A and B. Language editing certificate by was not properly provided. 3 Academic norms and rules: The conflict-of-interest disclosure was not properly provided, the Copyright License Agreement was provided. No academic misconduct was found in the CrossCheck search and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions. (2) The "Abstract" section is missing, and the information of authors and corresponding author is missing, please provide all missing parts. (3) The number of references is too small for a review. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
