The topic is within the scope of the WJH. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: The reviewer #00505584</p>	[Y]

thinks this is an interesting article with very honest results. The authors should add some commenting about minimally invasive approaches to gallbladder cancer. The authors cannot rule out bias and other potential 15 limitations so the study's conclusions must be interpreted with extreme caution. The reviewer#00068781 thinks the contents of this paper are rich and the statistical methods are used properly, which fully meet the requirements of this journal. The grammar needs to be revised. The reviewer #00069105 thinks the paper is well written, easy to read and the topic is interesting. But the experience is limited with only 19 cases so the amount of patients of each stage is small and the conclusions are not strong. TNM classification is not necessary to be included and the definition of radical/extended cholecystectomy is not adequate. (3) Format: There are 3 figures and 6 tables. A total of 79 references are cited, including 18 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by Edanz was provided. 3 Academic norms and rules: The authors did not provide the Institutional Review Board Approval Form, the Signed Informed Consent Form and the Biostatistics Review Certificate. The authors signed the Copyright License Agreement. The Conflict-of-Interest Disclosure Form was not provided properly. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support.
