The review is concisely written and easy to follow. The topic is timely and clinically of interest; and (3) Format: There is 1 figure. 	<p>published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are from United States. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The results of Bing search are eligible, but the CrossCheck detection showed a high similarity to published articles (total 6% and 5%). The authors need to rephrase the repeated sentences. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
