specify what does the Abbott Architect assay detect, HBsAg or HBeAg; 2) Please describe whether the HBV DNA test performed by PG Co; 3) Was not HAI (Knodell score) considered for determining fibrosis, if biopsies were available? 4) The purpose why CPHBV analysis in HBeAg+ and HBeAg- groups was performed is not clear. 5) Please check the numbers in Table 1 6) Correlation between CP and fibrosis is not shown. 7) The false positivity and negativity cases phenomenon is not discussed. Reviewer#02441021 pointed out that References should be listed as required. Reviewer#03721496 pointed out that 1) In Methods, in Quantification of liver fibrosis, the author should describe which classification is adopted to evaluate the inflammatory activity of liver tissues; 2) In Methods, How did the authors test whether the data distributed normally or not? 3) In Results, The authors should describe how to generate the equation. 4) In Results, the authors should present the median value of CPHBV with interquartile range. 5) In Discussion, the authors should add other limitations of the study; and (3) Format: There are 6 tables and a figure. A total of 39 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade 1A2B. A language editing certificate issued by Medjaden Bioscience Limited was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the Informed Consent Form(s) or Document(s), the signed Conflict-of-Interest Disclosure Form, the

Copyright License Agreement, and the Biostatistics Review Certificate. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) I found the title is more than 20 words. The title should be no more than 20 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add all the PMID and DOI in the reference list. Please provide all the PubMed numbers and DOI citation numbers to the reference list; and (5) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted. (Fang-Xin Fan)
