systematically reviewed the proteomic profiling of 4 of them. They also reviewed the role of niche on the proteomic profile of DSCs. The review was scientifically designed and useful to researchers interested in related area. However, the fifth kind of DSCs should also be discussed, and the language should be polished. The questions raised by the reviewer should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 49 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language editing certificate was not provided. 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form and Copyright License Agreement are not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) PMID and DOI numbers are missing in the reference list.
