The topic is within the scope of the WJGE. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer# 05207387 thinks this meta-study aim to evaluate the safety, efficacy, and feasibility of EUS-guided fiducial placement for pancreatic cancer undergoing image-guided radiotherapy. If a few revisions</p>	[Y]

are made, this manuscript will be a valuable meta-study to prove the effectiveness of the intervention. Such as: 1) "Study search" in meta-analysis is very important. Please enter a specific search period; 2) The criteria for inclusion and exclusion of research should be more specific; 3) the reviewer suggests the authors to change Figure 1 to the flow diagram style of "PRISMA"; 4) the reviewer encourages the author to add an evaluation of quality of studies to the results and discussions section; 5) The author needs to describe "Egger Bias" in detail in the Methods section; 6) In the Discussion section, the authors need to add more limitations of the study; and 7) the authors need to revise the conclusion section based on the results of the study; and (3) Format: There are 1 table and 5 figures. A total of 40 references are cited, including only 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. We suggest the authors to cite their own research work. 2 Language evaluation: Classification: Grade B. This manuscript is from United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and PRISMA checklist Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study was without any financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the WJGE. The
