the development process, advantages, current issues and controversies of watch and wait strategies for patients with locally advanced rectal cancer in detail. However, there are some points need to be addressed in the manuscript. Such as: 1) In the patient selection, the applicability and limitations of watch and wait strategies are suggested to be stated for patients with locally advanced rectal cancer who are at low or high risk of local recurrence; 2) some grammar errors should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 172 references are cited, including 37 references published in the last 3 years. There are no self-citations. We suggest the authors cite some their own research works in the review paper. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Londres was provided. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found there is no “Author contribution” section. Please provide the author contributions; and (2) I found the authors did not provide the original figures. Please provide the original figure documents.
