Scientific quality does not meet the publication standard of WJG. Reviewer#02954663 pointed out it is true that some statistical degrees of association between prevalence of H. pylori and the given disease was demonstrated,</p>	[Y]

	<p>but this, nevertheless, does not mean a cause-effect relationship and this fact is not at all emphasized in the manuscript. Although the manuscript is intended to present the extra-gastric manifestations of the H. pylori infection, some conditions such as inflammatory bowel diseases, GERD/esophageal carcinoma are also included and discussed, while in all these the role of bacteria could be even protective, but this is not discussed. Reviewer# 00503417 thinks this is a good review, but there are recent reviews on the same topic published elsewhere. Therefore, I suggest the Editorial Office director reject this manuscript.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor. I suggest a potential acceptance after major revision. The manuscript should be sent for re-review.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
