The topic is within the scope of the WJBC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The aim of this study was to estimate the prevalence of extended-spectrum</p>	[Y]

$\beta$ -lactamases-producing E. coli, and to identify the antibacterial susceptibility pattern of isolated bacteria. This study is interesting. However, there are some issues should be addressed. The authors need to add more details in the "method" section. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 31 references are cited, including 2 references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by NativeEnglishEdit.com was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement (file name: 55940-Signed Informed Consent). The authors need to provide original Institutional Review Board Approval Form and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the "Research Department of School of Medicine Shahid Beheshti University of Medical Sciences". The topic has not previously been published in the WJBC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I

found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (6) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (7) The authors need to provide original Institutional Review Board Approval Form and the informed consent. The authors need to fill out the STROBE checklist with page numbers. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
