The topic is within the scope of the WJCU. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is very simple and well written, the introduction is exhaustive, the tables are complete, the discussion is with a good readability. issues should be addressed. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 4 references are cited, including 1 reference published in the last 3 years. The authors need to add more literatures. There are no self-citations. 2 Language evaluation: Classification: Grade B. The manuscript is from the United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors, and original Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. The authors have published the “abstract” section ([https://www.jvir.org/article/S1051-0443\(18\)30619-5/fulltext](https://www.jvir.org/article/S1051-0443(18)30619-5/fulltext)). 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Institute of Health. The topic has not previously been published in the WJCU. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no “Author contribution” section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please
