	<p>medicine. The manuscript has a high scientific value. However, some questions raised by the reviewer should be answered; and (3) Format: There are 3 tables. A total of 135 references are cited, including 50 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors are from United States. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCO. 5 Issues raised: (1) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with minor revisions.
