(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The reviewer#04967668 finds the subject of the article very interesting for it is a very common clinical scenario encountered by</p>	[Y]

physicians all over the world during COVID-19 pandemic. However, for neither the scarce clinical examination report nor the CT scan result let us draw the conclusion that immediate surgery was really necessary. The results of histopathological analysis of the removed appendix with confirmation of the clinical diagnosis and the description of the severity of the inflammation are also interesting. Any surgery that prolongs hospital stay in comparison with conservative treatment is clearly unnecessary. (3) Format: There are 3 figures. A total of 12 references are cited, including 10 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support. The topic has not previously been published in the WJCC. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance. (Han Zhang)
