The topic is in the scope of WJD. (1) Classification: C and C. (2) Summary of the peer-review report: The topic of paper is very interesting and relevant. I would suggest authors to expel the one from USA and make their systematic review and meta-analysis country specific;</p>	[ Y ]

Please, also discuss the association between SARS-CoV-2 and DPP4 - the text requires minor language and technical polishing. (3) Format: 2 tables and 5 figures. 42 references were cited, including 35 references published in the last three years. No self-citation. 2 Language evaluation: A and B. Language editing certificate by LetPub was provided. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. The biostatistics review certificate was provided. The PRISMA 2009 Checklist was provided. No academic misconduct was found in the Bing search. The similar index is 40% and the single similar index is 7%, the repeated sentences have to be rephrased. 4 Supplementary comments: (1) Invited manuscript.
