A total of 30 references are cited, including 17 references published in the last 3 years. There are 10 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MEDEE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; the Capital Health Research and Development of Special Fund Program; and the Beijing Natural Science Foundation. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please provide the original figure documents.
