The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade C, and Grade C; (2) Summary of the Peer-Review Report: The authors analyzed the prognostic impact of coagulation disorder in 213 patients with COVID-19, which was very</p>	[Y]

meaningful. However, some questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 23 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, and Grade B. A language editing certificate issued by Elsevier Language Editing Express was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the Written informed consent was waived. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 12% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the

	<p>PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The “Article Highlights” section is missing.
