The topic is within the scope of the WJH. (1) Classification: Grade C, Grade C, and Grade E; (2) Summary of the Peer-Review Report: The study is well performed and the statistical evaluations seems to be completely correct, but the results are inconclusive. The questions raised by the reviewers should be carefully answered; and (3) Format: There are 4 tables and 2 figures. A total of 34 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Clinical Trial Registration Statement, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form, the Written informed consent, and the CONSORT 2010 Statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The language classification is Grade C.</p>	[Y]
