The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This was an interesting case with satisfying result, but some recent articles should be added in the manuscript;</p>	[Y]

and (3) Format: There is 1 figure. A total of 17 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C and Grade A. The author stated that if the Non-Native Speakers of English Editing Certificate was needed, he will send it via e-mail. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the Conflict-of-Interest Disclosure Form, Copyright License Agreement, and the Written informed consent, but all of which were not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Case Presentation" section were not written according to the Guidelines for Manuscript Preparation. Please re-write them, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required to send it to the Reviewer
