(1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: The authors presented a case of osteochondroma after avulsion fracture of anterior inferior iliac spine. osteochondroma and rectus femoris tendon insertion. The questions raised by the reviewers should be answered; and (3) Format: There are 9 figures. A total of 8 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, written informed consent, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 56246 (Withdraw). 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the "Case Presentation" did not meet our requirements.
