The topic is within the scope of the WJGE. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this exciting case of GOO, treated by EDGI of the excluded stomach, has been discussed. This is an unusual case which was efficiently managed by EDGI and angioembolization. However, there are some issues should be</p>	[Y]

addressed. The authors need to add a brief procedural description of gastro-gastrostomy. It would be worthwhile to introduce pre and post-angioembolization image. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 16 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. The authors need to fill out the CARE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. The corresponding author is the member of American College of Physicians. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list

	<p>and list all authors of the references. Please revise throughout; (4) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
