patients 'post-transplantation. At present, there are few reports of new coronary pneumonia in patients with LT, and we do not currently know whether COVID-19 will affect LT. The author's case report still needs further follow-up. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 23 references are cited, including 19 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide original informed consent signed by patients, and to fill out the CARE checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS",
