The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 73 references are cited, including 2 references published in the last 3 years. The authors need to update the references. There are 2 self-citations. 2 Language evaluation: Classification: Grade B. The manuscript is from the United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the ARRIVE Checklist form. The authors need to provide original Institutional Animal Care and Use Committee Approval Form. The Institutional Review Board Approval Form is not applicable. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Institute of Allergy and Infectious Diseases of the National Institutes of Health. The topic has not previously been published in the WJGPT. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found the authors did not provide the approved grant application form(s).
