As there has been no accurate guideline in this field, it is difficult to evaluate this kind of articles, but their idea might be acceptable from general consideration. (3) Format: Without tables and figures. 31 references were cited, including 17 references published in the last three years. No self-citation. 2 Language evaluation: Grade B, B and C. Language editing certificate was not properly provided. Please provide language certificate by language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure form and Copyright License Agreement were provided. No academic misconduct was found in the Bing search and CrossCheck search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG. 5 Issues raised: (1) The PMID and DOI numbers of references are missing. Please add PMID and DOI numbers. (2) The “author contributions” section is missing. Please add this section ahead of the section “Abstract”. (3) The number of references is too small for an opinion review, please add some more references. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
