Report: The authors reported the diagnostic usefulness of ultrasonography for assessing the activity of inflammatory bowel disease compared to MRE and colonoscopy. The manuscript is well written, and the observational study summarizes the key findings. The total number of cases is small, including ulcerative colitis and Crohn's disease, and the number of cases of a single disease is less. It is suggested to increase the number of cases. It is suggested to increase the analysis of correlation between clinical and imaging indexes. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 33 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B and Grade C. A language editing certificate issued by American Manuscript Editors was provided. The language needs to be further improved. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the
