in this important and growing group of patients. However, there are some issues should be addressed. The abstract probably can be organized into the goals, methods and findings in a succinct way. Please also discuss the benefits of bariatric surgeries to obesity and type 2 diabetes. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 189 references are cited, including 56 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
