2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an opinion review of the Lenvatinib as first-line for recurrent HCC after liver transplantation. The topic is within the scope of the WJT. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: This paper focused on the treatment of HCC recurrence after liver transplantation by citing their own experience and reviewing the literature. And the topic of this paper was</p>	[Y]

attractive and interesting. However, the case cited by the authors did not fit the topic of the paper well. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 55 references are cited, including 17 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade A and Grade A. The language was edited by a native English speaker. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 11% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJT. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required by Reviewer 05121731. 7 Recommendation: Conditional acceptance.
