2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a Randomized controlled trial of the total hip arthroplasty. The topic is within the scope of the WJO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting study. However, there are some issues should be addressed. Sample size calculation should be more clearly</p>	[Y]

expressed. Since the follow-up period of this study is only 5 years, clinical significance may be limited. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 6 figures. A total of 47 references are cited, including 5 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the CONSORT checklist form, Clinical Trial Registration Statement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all

	<p>authors of the references. Please revise throughout; (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (6) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
