The topic is within the scope of the AIC. (1) Classification: Grade A, Grade A, Grade A, Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors presented a review of the recent use of artificial intelligence methods in oncology. The manuscript was interesting and well-written. However, some small reference to soft computing and to molecular pathological epidemiology should be added. The</p>	[Y]

questions raised by the reviewers should be answered; and (3) Format: There are no tables and figures, we suggest to add some figures or tables. A total of 33 references are cited, including 22 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade A, Grade A, and Grade A. The authors stated that the language of the manuscript is suitable for publication. 3 Academic norms and rules: The author provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 4 grants. The topic has not previously been published in the AIC. 5 Issues raised: The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required by Reviewer 03093768, Reviewer 03892684 and Reviewer 02856239. 7 Recommendation: Conditional acceptance.
