steps of CNN utilisation and shed some light on some of the studies that showed artificial intelligence improve the diagnosis and detection of GI pathology such as polyps. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 9 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades A, Grade B, Grade D. The authors are native English speakers. 3 Academic norms and rules: The authors provided the the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIGE. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

	<p>the science editor. The scientific quality does not meet the publication standard. Two reviewers suggest that the manuscript should be rejected.
