The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors conducted an excellent, comprehensive and broad review of the rare entity. They also added a schema proposing a new classification for this rare type of tumor that is really clear concise and very helpful for clinician in</p>	[Y]

order to guide their treatment strategies. The language is excellent and highly pedagogic providing newcomers to the field and students with a great opportunity to have an overview of this rare tumor. However, below some minor comments for further clarifications. Page 43: In the proposed classification diagram: there is some contradiction in the intermediate and low-grade categories as they both have adenoma and NET low grade. Please clarify. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 139 references are cited, including 40 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I have changed the manuscript type "review" to "systematic review". The authors need to provide the Biostatistics Review Certificate and fill out PRISMA checklist form with page numbers. Please revise the manuscript according to the Guidelines and Requirements for "systematic review"; (2) I found the authors did not provide the original figures. Please

	<p>provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (5) the authors need to provide an editable manuscript (format: .doc or .docx). 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
