1 the methodology is good, the objectives are clear and the scientific contribution is indisputable. However, there are some issues should be addressed. The very differing follow-up periods in both groups of your patients should be mentioned in the limitation section of your discussion. There is no presentation of SF-36 in the methods section. The indications of surgery were not clear. The questions raised by the reviewers should be answered; and (3) Format: There are 9 tables and 3 figures. A total of 28 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
