The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This manuscript is in generally well done, but some spelling mistakes should be revised; and (3) Format: There is 1 table. A total of 18 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation:</p> | [Y] |

Classification: Grade B. The authors didn't provide the language editing certificate. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement, but the Conflict-of-Interest Disclosure Form is not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor.

Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted. I have sent the manuscript to the author(s) for its revision according to the Peer-Review Report, Editorial Office's comments and the Criteria for Manuscript Revision by Authors.
