2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a prospective study of the hemoadsorption by CytoSorb® in sepsis patients. The topic is within the scope of the WJCCM. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The report on a prospective study of treatment effects of the</p>	[Y]

CytoSorb® therapy used as an adjunctive therapy along with standard of care in Septic patients admitted to intensive care unit. Both primary and secondary outcomes were evaluated. The findings offer insightful details on the timing of the CytoSorb treatment and safety. Although the limitations are documented, the sample size is relatively small and may not be generalizable to other patients. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 41 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Clinical Trial Registration Statement, and the CONSORT checklist form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCCM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or

	<p>arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
