manuscript. Case definitions followed as per guidelines. Appropriate statistical analysis was done, and authors described results well. Tables and graphs are useful in understanding the results. In the discussion authors well described limitation such as sample size, single center study. No pathophysiology behind the results; and (3) Format: There are 4 tables and 3 figures. A total of 21 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE checklist form. No academic misconduct was found in the Bing search. The authors have published preprint (<https://www.medrxiv.org/content/10.1101/2020.03.25.20043570v1>). 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; and the Nanjing Medical Science and Technology Development Foundation. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
