The topic is within the scope of the WJC. (1) Classification: Grade D, Grade B and Grade A; (2) Summary of the Peer-Review Report: The authors reported a very relevant topic as inappropriate ICD shocks can have negative effects on the patient's</p>	[Y]

health. Essential clinical, morphological, and immunohistochemical data were given. However, the authors should add some detail describing the form of remote monitoring that was applied. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 23 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
