information will be a valuable scientific contribution to our field. Although relatively low number of subjects (196) included this manuscript does an excellent job demonstrating magnitude of individual genetic profile and incidence of HIT & TE after TJA. However, there are some issues should be addressed. Observational prospective experimental design requires the calculation of sample size. It is not seen in the article. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 30 references are cited, including 4 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, Institutional Review Board Approval Form, and the informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Hellenic Association of Orthopaedics Surgery and Traumatology. The topic has not previously been published in the WJO. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original
