The topic is within the scope of the WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reported an interesting manuscript as it is a retrospective analysis of different treatment modalities on this highly poor prognosis as well as a rare group of esophageal carcinoma. However, the questions raised by the reviewer should</p>	[Y]

be answered; and (3) Format: There are 4 tables and 2 figures. A total of 18 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Written informed consent, and the STROBE Statement are not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
